**OFFICE MEMORANDUM**

**Subject: Constitution of Working Group on "FutureLabs AI Compute Capacity IndiaAI"**

The undersigned is directed to convey the approval of the Competent Authority to the constitution of Working Group on "FutureLabs AI Compute Capacity IndiaAI". The Vision, Objectives, Proposed Mechanism and Composition of the Working Group are given in succeeding paras.

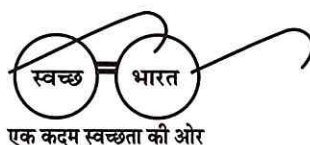
**Vision:** For realizing the vision of "Make AI in India and Make AI work for India", streamlined access to compute infrastructure is critical. Leading AI compute infrastructure will act as the kinetic enabler for the start-up and innovation ecosystem, helping organizations develop commercially viable AI applications.

**Objectives for the Multi-stakeholder Group:** A multi-stakeholder group is being formed, through voluntary participation, to collaboratively conceptualize the model for providing access to compute. The model of the compute (services) should address the following considerations:

1. Identify and prioritize use cases that can be addressed using the compute infrastructure
2. Mechanisms to ensure adoption by relevant stakeholders such as start-ups, research labs, academic institutions, etc.
3. Establish metrics and evaluation frameworks to measure the impact of the compute infrastructure on start-ups and innovation
4. Utilising Compute for scaling up and commercialization of AI solutions

**Proposed Mechanism:**

1. The multi-stakeholder group will commence the activity from the date of issue of this OM and submit the final document within 30 days. In order to review the progress, CEO IndiaAI will hold a meeting with the Chairmen of each multi-stakeholder group once a week.



2. Additional members may be co-opted by the Chair following approval from the CEO, IndiaAI.
